WA State Initiative 297

Requiring contaminated sites, such as Hanford, to be cleaned up before more waste can be added; stops dumping of nuclear waste in unlined soil ditches. *(46th LD adopted resolution supporting I-297 on August 27, 2003)*

Reducing the size of the King County Council from 13 to 9 members. *(46th LD adopted resolution opposing on November 20, 2003)*
